2020 ACW HEALTH & SAFETY UPDATE

Due to COVID-19 all 24 child care locations were closed as of March 13, 2020. It was identified early that communication was not streamlined – the ACW staff portal became the main mode of keeping communication open, and for sending updates regarding reopening. New COVID-19 protocols, policies, and additional trainings were shared via the ACW staff portal. Employees would receive a notification email when the protocols were updated and a sign off was sometimes required. The

ACW staff portal has been used for doing online training but with COVID-19 it became critical for communication. All employees have their own username and the use of the staff portal as a means of communication has been a success for our employees. In 2020 the Safety Program was changed to the WSIB "Excellence Program". The Excellence program is designed to help companies manage a system for health and safety in the workplace. This is accomplished through mentoring, pooling of resources and sharing of best practices between members, Dunk & Associates (our sponsor), and the WSIB. Excellence program members can reduce workplace injuries and illnesses and be rewarded with rebates on WSIB premiums. As part of the program, a

small survey on the Excellence dashboard through WSIB was completed. 5 topics were chosen to ensure we had a policy, communicate & train those who were required, evaluate the success and finally acknowledge our success. Due to COVID, this process was difficult, however, once we were able to open again our staff portal was used to complete the training and evaluate the topics chosen for the 2020 program. Once completed, all evidence for the 5 topics were submitted.

ACW was successful and received a rebate of \$6,452.32. As well, for our work in Safety Group in 2019 we received a rebate of \$4,326.93 and our NEER rebate was \$7,045.52.



2020 PROGRAM UPDATES

2020 was an interesting year to say the least, however ACW continues to focus on some of the positive

changes that took place. In November, we opened up two new sites in St. Catharines and that was a great reason to celebrate. ACW- Fairview located at 184 Scott Street provides care for infants, toddlers, preschool children and the centre will expand care to include school attenders in the future. ACW – North Court located at 111 Church Street provides care for toddler and preschool children.

ACW - Tiny Travellers children and Educators had a lovely surprise in December when their playground was secretly updated to include naturalized items over

the weekend. When the children and Educators came into the centre on the following Monday they were excited about the transformation that took place in their outdoor play space.
