2022 was yet another year of change for the Early Learning/Child Care sector. The beginning of 2022 continued with the temporary closures of schools and child care centres due to COVID. We then slowly moved into more pre-pandemic procedures confidently inviting parents back into the centres. As we continued to operate at our nineteen child care locations, we are reminded of the critical need for childcare and the changes that have taken place in our sector.

In May, A Child's World successfully implemented a new platform called Digibot. This is a web-based platform used by the child care centres and parents to book child care needs, collect fees from families, provide documentation, and record activities as they happen throughout the day. It is used to keep families informed on everything from nutritional information to fun moments and learning activities. The rollout of the new system was very successful, we have had lots of great feedback from families and staff alike.

A Child's World was excited to support Parents and Educators by signing onto the Canada Wide Early Learning and Child Care Plan (CWELCC). The implementation of this plan has been very positive for parents of young children in the reduction of child care fees. With the new plan came the increased desire for child care spaces. Operating at approximately 60-70% of our licensed spaces has proven extremely frustrating for parents requiring a child care space. A Child's World still continues to deal with an Educator crisis which regrettably has not seen a reprieve. There is no doubt that when the implementation of CWELCC is complete, child care may be transformed in ways that are still unknown. The challenge with managing services and people through yet another transformation is to figure out the right balance; especially in the areas of recruitment, retention, procedures, as well as financial viability. We would like to thank everyone for their patience and understanding as we continue to work through these changes.

During the Fall of 2022, the Board of Directors and I engaged in successfully developing a 5-year Strategic Plan for 2023-2028. A Child's Worlds main priority is to maintain and improve our operational excellence in all we do, staying true to our mission of providing quality learning and childcare in Niagara. We also celebrated our greatest asset, our dedicated Educators, by planning an evening of festivities and professional development supported by a Child Care and Early Years Workforce Professional Learning Grant. The evening supported Educators mental health and well-being through tangible self-care tools, teachings on work-life balance, and strategies to navigate stress and burnout. I would like to take this time to thank and acknowledge the hard work and dedication of every Educator employed by A Child's World. All ACW Educators are committed to nurturing the emotional, social and cognitive skills children need to become lifelong learners. They play a critical role in children's development. Their important work inspires young minds and builds strong communities for our future. They also support the well-being of families and deserve to be recognized for all they do each and every day! I would also like to extend a thank you to all parents and members of the Board of Directors as well as our community partners. You all play a critical role in A Child's Worlds ongoing success.

Centre monthly inspections were able to resume in person as well. Compliance packages were available on our staff portal for all Educators and Management to complete. In 2022, A Child's World was once again part of the WSIB "Excellence Program". The 3 topics ACW completed to participate in the program and receive recognition from WSIB was Control of Records, Return to work program and Supervisor competency. Incidents and medical leaves decreased within the Organization in 2022 compared to 2021.

The Foundation for Quality Child Care is a registered charity and can issue official income tax receipts for the gifts it receives from personal and corporate donors.















TOTAL REVENUE \$9,004,421

TOTAL EXPENSES \$ 9,684,187


